

Bids must be valid for a period of 90 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. 200,000.00 which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 Days)
